

Amazon Relay 2026 Prime Day Onboarding Promotion Terms and Conditions

Effective Date: May 18, 2026

Welcome to the Amazon Relay 2026 Prime Day Onboarding Promotion. Amazon Logistics LLC and/or its affiliates (herein referred to as "Company" or "we") are offering eligible motor carriers the opportunity to participate in a promotional incentive program (the "Promotion"), subject to the terms and conditions herein ("Promotional Terms"). These Promotional Terms are in addition to any agreements between you and the Company relating to Amazon Relay, including the [Amazon Relay Terms](#), the [Amazon.com Conditions of Use](#) and the [Amazon.com Privacy Notice](#), each of which is incorporated herein by reference (collectively, the "Relay Terms"). To the extent these Promotional Terms are inconsistent with the Relay Terms, these Promotional Terms will control solely with respect to this Promotion.

By participating in this Promotion, you agree to these Promotional Terms and the Relay Terms incorporated herein by reference. If you do not agree, do not participate in the Promotion.

Promotion Period

The Promotion begins at 12:01 a.m. PT on June 8, 2026, and ends at 11:59 p.m. PT July 11, 2026 (the "Promotion Period"). This Promotion Period applies only to the Amazon Relay 2026 Prime Day Onboarding Promotion.

Promotion Overview

Eligible motor carriers ("Participants") that satisfy the eligibility criteria below will receive one \$1500 incentive payment (the "Incentive"), subject to Amazon's verification of eligibility under these Promotional Terms.

Eligibility

To be eligible for the Incentive, you must: (1) be a motor carrier that enrolled in the Promotion by completing and submitting the form found on [relay.amazon.com/prime](#) on or before 11:59 p.m. PT on July 11, 2026; (2) complete your application to haul with Amazon Relay, including submission of all required documents and information, on or before 11:59 p.m. PT on July 11, 2026; (3) have valid and active insurance on file with RMIS; (4) receive approval to haul in the Relay program on or before 11:59 p.m. PT on July 11, 2026; (5) book at least 7 loads for Amazon using Relay's load board during the Promotion Period; and (6) complete at least 7 loads using Relay's load board using eligible Relay drivers during the Promotion Period. Trips cancelled by Amazon or rejected by your company do not qualify as completed loads for purposes of this Promotion.

This Promotion is available only to the motor carrier who completed and submitted the enrollment form on [relay.amazon.com/Prime](#) and may not be transferred, assigned, shared, or forwarded to any other person or entity. Limit one (1) Incentive per eligible recipient / company account.

Eligibility will be determined by Amazon based on satisfaction of the criteria above. Amazon may deny or reverse an Incentive if Amazon reasonably determines that you: (1) did not satisfy the eligibility criteria; (2) engaged in fraud, abuse, misuse, or other misconduct in connection with the Promotion; (3) used an automated system, artificial device, or other improper means to participate in or benefit from

the Promotion; (4) received the Incentive in error; or (5) violated these Promotional Terms, the Relay Terms, or applicable law.

Incentive Delivery

If you satisfy the eligibility criteria and Amazon verifies your eligibility, Amazon will issue one (1) \$1,500 Incentive to your company within 30 days after the end of the Promotion Period and verification of eligibility.

The Incentive will be paid using the payment method or payment process associated with your Relay account, or such other method as Amazon may reasonably determine for operational purposes.

You are solely responsible for any taxes associated with the Incentive. Amazon may issue tax reporting documentation to the extent required by applicable law.

Changes, Suspension, or Termination

To the maximum extent permitted by applicable law, Amazon reserves the right to modify, suspend, or terminate the Promotion, in whole or in part, at any time and for any reason, including due to fraud, misuse, technical failures, legal or regulatory requirements, or operational issues.

Amazon may, but is not required to except where required by applicable law, provide notice of material changes to the primary administrator email address associated with your Relay account. Any such changes will be effective as of the date stated in the notice. By continuing to participate in the Promotion after the effective date of any revised Promotional Terms, you agree to the revised Promotional Terms.

Amazon will interpret and apply these Promotional Terms in its discretion, to the maximum extent permitted by applicable law. Amazon's decisions regarding eligibility, verification, administration of the Promotion, and payment, denial, or reversal of any Incentive will be final, subject to applicable law.

Release; Limitation of Liability

By participating in the Promotion, and to the fullest extent permitted by applicable law, you release Amazon and its third-party service providers, affiliates, directors, officers, employees, agents and contractors (collectively, the "Released Party") from responsibility, liability, claims, demands and/or damages (actual and consequential) of every kind and nature, known or unknown, arising out of or related to the Promotion, including but not limited to, interruptions or errors of the Promotion and use of any Incentive that you accept.

You agree to indemnify and hold harmless the Released Party from and against any loss, damage, liability, cost, or expense of any kind (including attorneys' fees) arising from your participation in the Promotion, any fraud or misuse in connection with the Promotion, violation of any applicable law or the rights of any third party. This indemnity is in addition to, and not in lieu of, any other indemnities set forth in a written agreement between you and Amazon.

Governing Terms for Disputes

Any dispute, claim, or controversy relating in any way to the Promotion or these Promotional Terms will be governed by the dispute resolution, arbitration, class-action waiver, governing law, and venue provisions in the [Amazon Relay Terms](#), which are incorporated into these Promotional Terms by reference.

Severability

If any provision of these Promotional Terms is found to be invalid or unenforceable, that provision will be deemed severable and the remaining provisions will remain in full force and effect.

Privacy

Any information submitted by you in connection with the Promotion will be treated in accordance with the Relay Terms, specifically including Amazon's [Privacy Notice](#).

By participating in the Promotion, you acknowledge that you have reviewed the applicable Relay Terms and privacy notice. Amazon may send communications regarding administration of the Promotion and payment of the Incentive to the primary administrator email address associated with your Relay account.
