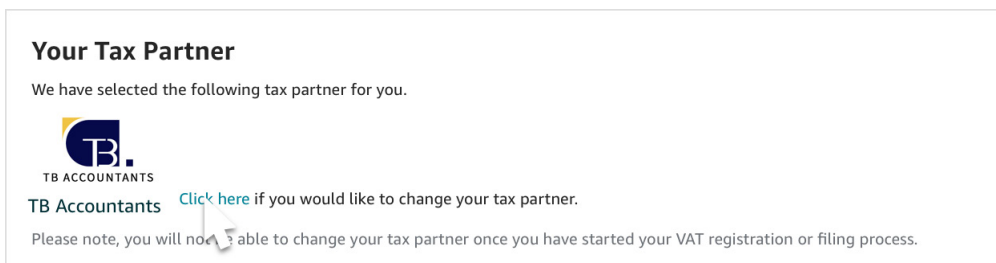

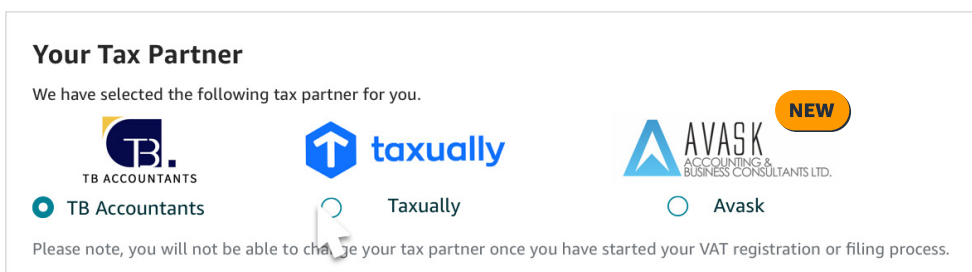
We have selected experienced and trusted tax service providers in Europe to bring you support at a cost-effective fee in multiple geographical locations.
