

## Customs Clearance & Shipping Services (C2S2) New Seller Sign-Up Offer: 3 FREE Brokerage Fees

### 1. Offer Overview

New Sellers who have never shipped with C2S2 will receive **3 shipment brokerage fees FREE** (increased from the standard 1 FREE brokerage fee) plus the **1st year Indirect Representation (IR) FREE**, when they sign up and ship using C2S2's Small Parcel Delivery (SPD) or Less than Truckload (LTL) solutions with either AVASK or RXO as their broker.

### 2. Offer Duration

- **Offer Period:** 1st May 2026 – 31st July 2026
- **Shipping Deadline:** All 3 qualifying shipments must be shipped by **31st August 2026**
- **Post-Offer Reversion:** After 31st August 2026, the standard sign-up offer of **1 FREE shipment brokerage fee** will automatically apply. If you have already used 1 FREE shipment brokerage fee, and a shipment is made after 31 August 2026, then the offer will be expired.

### 3. Target Audience – New Sellers

A "New Seller" is defined as any FBA Selling Partner who has **never shipped with C2S2**, regardless of:

- Whether they have already signed up for the C2S2 service or signed a power of attorney (POA) with AVASK or RXO
- Whether they have not yet signed up with C2S2 at all

### 4. Offer Structure

#### a. Brokerage Fee Benefit

- **3 shipment brokerage fees FREE** per eligible New Seller
- This offer may only apply to **one broker**; it will apply for the 3 free shipment brokerage fees (the broker chosen by the New Seller for first shipment will be the default selection) if completed within the Shipping Deadline

#### b. Indirect Representation (IR) Benefit

- **1st year IR FREE** (unchanged from current sign-up offer)
- The 1<sup>st</sup> year IR Free offer will not apply to New Sellers who already received the 1<sup>st</sup> year IR Free under the prior sign-up offer, but who have not yet shipped with C2S2 – these New Sellers are only eligible for the 3 shipment brokerage fees Free offer

### 5. Claiming Reimbursement

- Shipment brokerage fees will be promptly reimbursed, with typical offer payment in the next month (on or about 30 days).
- The New Seller must pay its shipment brokerage fee first.
- Your broker (AVASK or RXO) will subsequently provide credit to the New Seller in the amount of the applicable shipment brokerage fee (per the above terms).
