

Refer a Friend – Terms and Conditions

1. In recognition of your success and performance on www.amazon.in ("**Amazon Site**"), Amazon Seller Services Private Limited ("**Amazon**", "**we**", "**us**" or "**our**") is pleased to invite you to participate in the Refer a Friend ("**Promotion**") under the Amazon Seller Rewards Program ("**Program**").
2. These Promotion terms and conditions ("**Terms**") are in addition to terms and conditions of the Program ("**Rewards Program Terms**") accepted by you. Only with respect to this Promotion, in the event of any conflict in the provisions of the Rewards Program Terms and these Terms, these Terms shall prevail. All capitalized terms not defined in these Terms have the respective meanings set forth in the Rewards Program Terms.
3. The Promotion will commence at 00:00:00 hrs. (IST) on January 1st, 2025 and end at 23:59:59 hrs. (IST) on June 30th, 2025 ("**Promotion Period**") unless revoked by Amazon in its sole discretion without any prior notice.
4.  - Referee gets launch as a seller on the Amazon Site within 30 days from the date of registration.
6. You and the Referee will only be eligible for Rewards under this Promotion, if such Referee:
 - Conducts business in India;
 - Deals in product categories available on the Amazon Site;
 - Possess a valid and applicable GST registration; and
 - Referee's contact details are not already available in the Amazon database.
