

Flat 50% waiver on Referral Fee across categories for sellers registering from January 15, 2023 to April 14, 2023

1. This limited term offer is offered by Amazon Seller Services Private Limited ("**Amazon**", "**we**", "**us**" or "**our**").
2. This Referral Fee waiver Offer ("**Offer**") is available to India-based sellers who register (complete sign up to their Amazon Seller Central account and enter their company name) on sell.amazon.in website or the mobile application thereof (collectively, "**Site**") in accordance with the terms and conditions of this Offer ("**Offer Terms**").
3. This Offer is valid for sellers registering on the Site from January 15, 2023 to April 14, 2023 (both days inclusive) ("**Offer Period**"), unless extended or revoked by Amazon in its sole discretion.
