

Flat 50% waiver on Referral Fee across categories for sellers registering from registered after September 1, 2022, but not launched as of January 14, 2023

1. This limited term offer is offered by Amazon Seller Services Private Limited ("**Amazon**", "**we**", "**us**" or "**our**").
2. This Referral Fee waiver ("**Offer**") is available to India-based sellers who have registered (completed sign up to their Amazon Seller Central account and entered their legal entity name) on sell.amazon.in website or the mobile application thereof ("collectively, **Site**") after September 1, 2022, but not launched (not completed listing of at least one product on the Site) as of January 14, 2023, in accordance with the terms and conditions of this Offer ("**Offer Terms**").
3. This Offer is valid for referral fee payable from January 15, 2023 to March 15, 2023 (both days inclusive) ("**Offer Period**"), unless extended or revoked by Amazon in its sole discretion.
