

Flat 50% waiver on Referral Fee across categories for sellers registering from registered after December 1, 2022, but not launched as of May 9, 2023

1. This limited term offer is offered by Amazon Seller Services Private Limited ("**Amazon**", "**we**", "**us**" or "**our**").
2. This Referral Fee waiver ("**Offer**") is available to India-based sellers who have registered (completed sign up to their Amazon Seller Central account and entered their legal entity name) on sell.amazon.in website or the mobile application thereof ("collectively, **Site**") December 1, 2022, but not launched (not completed listing of at least one product on the Site) as of May 9, 2023, in accordance with the terms and conditions of this Offer ("**Offer Terms**").
