

One-Year Limited Warranty for Pinzon Products

This limited warranty is provided by the entity listed in the table below to you as the original purchaser of the Pinzon-branded product(s) (the "Product"). **The Product may be manufactured by a third party not affiliated with Amazon.**

We warrant the Product against defects in materials and workmanship under ordinary use for one year from the date of your original retail purchase from us, except that if the Product is a consumable product (for example, an ink cartridge), this limited warranty is null and void as soon as the consumable part of the Product (for example, the ink) has been consumed. In all cases, Product comparability will be determined by us at our sole discretion.

This limited warranty applies only to hardware components of the Product that are not subject to accident, misuse, neglect, fire or damage from other external causes, alteration, repair, or commercial use. This limited warranty is not transferable to any subsequent purchaser or recipient of the Product.

This limited warranty applies to any replacement Product or part, or to any repair, for the remainder of the original warranty period or for 90 days from its shipment to you, whichever period is longer. All parts and Products that you return to us and for which we give you a refund or replacement will become our property upon our receipt.
