Now it is time to consider how you can maximize the fun and excitement your equipment offers. Harman Kardon and the Consumer Electronics Association want you to get the most out of your equipment by playing it at a safe level: one that lets the sound come through loud and clear without annoying blaring or distortion – and, most important, without affecting your sensitive hearing.

Sound can be deceiving. Over time your hearing “comfort level” adapts to higher volumes of sound. What sounds “normal” can actually be loud and harmful to your hearing. Guard against this by choosing a safe level BEFORE your hearing adapts.

### TO ESTABLISH A SAFE LEVEL:

- Start your volume control at a low setting
- Slowly increase the sound until you can hear it comfortably, clearly, and without distortion

### ONCE YOU HAVE ESTABLISHED A COMFORTABLE SOUND LEVEL:

- Do not exceed that level



Taking a moment to do this now will help to prevent hearing damage or loss in the future. After all, we want you listening for a lifetime.

## Harman Kardon 5-Year Limited Warranty — Loudspeakers

**U.S. Warranty – For warranty information outside the U.S., please contact your local distributor.**

*Warranty service is only available in the country of original purchase. This is an important document.*

*Attach your bill of sale to this card and keep it in a safe place. Your bill of sale is your warranty.*

The Harman Kardon warranty on the electronic components in this loudspeaker system remains in effect for **one year** from the date of the first consumer purchase.

The Harman Kardon warranty on loudspeakers (except enclosures) remains in effect for **five years** from the date of the first consumer purchase. Enclosures are warranted for **two years** from the date of purchase.

### **WHO IS PROTECTED BY THIS WARRANTY**

The Harman Kardon warranty protects the original owner and all subsequent owners, provided that the Harman Kardon product was purchased within the continental United States, Alaska or Hawaii from an authorized dealer who was authorized by Harman Kardon to sell such products at the time of the original purchase, or purchased by military personnel from an authorized military outlet. **A copy of the original dated bill of sale must be presented whenever warranty service is required.**

### **WHAT IS COVERED BY THIS WARRANTY**

Except as specified below, the Harman Kardon warranty covers all defects in material and workmanship. The following are **not** covered: damage caused by accident, misuse, abuse, product modification or neglect; damage occurring during shipment; damage from failure to follow instructions contained in the instruction manual; damage resulting from the performance of repairs by someone not authorized by Harman Kardon; damage caused by installation of parts that do not conform to Harman Kardon specifications; units used for other than home use; units not used for their intended purpose; any claims based on misrepresentations by the seller; products sold on an "as is" or final-sale basis; or the cost of installing, removing or reinstalling the unit. Harman Kardon's liability is limited to the repair or replacement, at our option, of any defective product and shall not include incidental or consequential damages. Harman Kardon reserves the right to replace a discontinued model with a comparable model. Any replacement units or parts may be new or rebuilt.

**NOTE:** Repair of our product must be done by an authorized dealer or service center. **Unauthorized repair will void the warranty and is done at the risk of the consumer.**

### **TO OBTAIN WARRANTY SERVICE**

If you require warranty service, please return the product to your dealer. If this is not possible and you live in the United States, please visit our Web site at [www.harmankardon.com](http://www.harmankardon.com), or call 516-255-HKHK (4545) for information on how to obtain service or replacement.

If purchased outside the United States, contact your local dealer or distributor for repair or replacement.

### **DO NOT RETURN PRODUCTS TO THE HARMAN KARDON FACTORY WITHOUT AUTHORIZATION; THEY WILL BE RETURNED UNOPENED**

You are responsible for transporting your product for repair or replacement. Harman Kardon will pay reasonable return charges for delivery to any location in the continental United States, Alaska or Hawaii if the repair or replacement is covered under the warranty. Please save the original shipping carton(s), as a charge will be made for additional cartons.
