

## Slime Limited Warranty

ITW Global Tire Repair Inc. (“ITWGTR”) warrants that its Slime branded products (“Products”) will be free from manufacturing defects for the applicable Warranty Period as follows. This warranty does not cover any defects due to normal wear and tear, damage due to misuse, abuse or unsafe use, claimant’s failure to follow the operating instructions, alteration to the product, or negligence.

Sealant	Two years from the date of purchase
Inflator	One year from date of purchase Inflator: One year from date of purchase
Flat Tire Repair Kits	Sealant: Four years from date of manufacture (the manufacturing date is printed in code on the product packaging; for details on how to translate the production date code into the manufacturing date, please visit our <a href="#">FAQs</a> )
Bicycle Tube	Two years from date of installation
Gauges and Tire Accessories	One year from date of purchase

Because ITWGTR cannot control the quality of products sold by unauthorized sellers, this warranty applies only to Products that were purchased from ITWGTR or an ITWGTR authorized seller, unless otherwise prohibited by law. ITWGTR reserves the right to reject warranty claims for Products purchased from unauthorized sellers, including unauthorized Internet sites.

ITWGTR reserves the right to verify that the information mailed by claimant supports claimant's entitlement to warranty coverage. The sole remedy for any approved warranty claim is a replacement product or a refund of the purchase price.

There are no warranties which extend beyond those stated herein. Any implied warranties that may be applicable to Products, including implied warranties of merchantability or fitness for a particular purpose, are limited in duration to the duration of this warranty.
