

## Betta Solar-Powered Pool Skimmer Warranty

The Betta Solar-Powered Pool Skimmer has been manufactured, tested, and inspected to meet precise engineering specifications. It comes with a warranty, ensuring it is free from defects in materials and workmanship during regular usage and service, while also being subject to certain qualifications, conditions, and limitations detailed below.

- This warranty covers the initial consumer or purchaser for a duration of 1-year, commencing from the date of purchase.
- This warranty is only applicable within the United States. If the product is used outside of the US, the warranty will be invalidated.
- The Betta Solar-Powered Pool Skimmer is engineered to function effectively in saline water with levels of up to 5000 P.P.M. However, using the unit in saltwater pools will void the warranty.
- This warranty specifically applies to the standard and reasonable utilization of the unit, focusing solely on manufacturing defects. Any damage, flaws, operational issues, or failures resulting from usage that deviates from the instructions in the operator's manual, as well as the purchaser's failure to perform reasonable and necessary maintenance, will render this warranty void.
- Damage, defects, malfunctions, or other failures caused by or related to repairs performed by any service station or person other than an authorized service representative of Betta shall not be covered.
- The use of any electrical components other than originally manufactured by BettaBot will invalidate the warranty.

BettaBot Inc. hereby renounces any and all claims, and the purchaser absolves BettaBot from any claims related to damages incurred to their pool's plaster or vinyl liner due to the use and operation of the Betta Solar-Powered Pool Skimmer.

The warranty responsibilities of BettaBot shall be confined to either repairing or replacing the product or any defective component, as determined by BettaBot. This repair or replacement may encompass the utilization of refurbished components and/or units, as decided by BettaBot.
