

## **Easy Pro 1-Year manufacturer's warranty**

(Warranty covers all parts, labor, and even normal wear and tear)

### **Warranty/Disclaimer:**

JFJ EASY PRO ("JFJ") warrants this unit free of defects in materials and workmanship for a period of one (1) year from the date of purchase. In addition to JFJ's standard warranty period, JFJ will extend the warranty period for one (1) or five (5) additional years if the extended warranty is purchased before JFJ's standard warranty expires.

If the unit should malfunction, it must be returned to the factory for evaluation, and all costs of shipping shall be borne solely by the purchaser. JFJ's Customer Service Department will issue a Return Authorization (RA) number immediately upon phone or written request. Upon examination by JFJ, if the unit is found to be defective it will be repaired or replaced at no charge (refer to warranty terms and conditions). JFJ's WARRANTY does not apply to defects resulting from any action of the purchaser, including but not limited to mishandling, improper interfacing, operation outside of design limits, improper repair, use of any other product other than JFJ products, or unauthorized modification. This WARRANTY is VOID if the unit shows evidence of having been tampered with (broken seal) or shows evidence of being damaged as a result of use of non JFJ products/supplies, excessive corrosion; or current, heat, moisture or vibration; improper specification; misapplication; misuse; abuse or other operating conditions outside of JFJ's control.

This warranty is non-transferable and does not apply to any purchaser who bought the product from a reseller or distributor not authorized by JFJ, including but not limited to purchases from internet auction sites.
