Limited 2-Year Warranty For ZipWall® ZP2, ZP4, SLP2, SLP4, KT20, FR2, SPN, SDPK, SC2, MDK and ZipFast™ Reusable Barrier Panels

Limited Warranty

ZipWall® ZP2, ZP4, SLP2, SLP4, KT20, FR2, SPN, SDPK, SC2, MDK and ZipFast™ reusable barrier panels are warranted against defects in materials and workmanship for a period of two (2) years from date of purchase. This warranty applies only to the original owner (evidenced by sales receipt). It specifically excludes any damage or failure due to abuse, misuse, abnormal or improper use, neglect, improper maintenance or alterations or modifications by anyone other than ZipWall® LLC.

Remedies

Your exclusive remedy under this Limited Warranty is that ZipWall® LLC, at its option, will repair or replace, without charge for parts and/or labor, any ZP2, ZP4, SLP2, SLP4, KT20, FR2, SPN, SDPK, SC2, MDK and ZipFast™ reusable barrier panels that fails due to a defect in materials or workmanship during the 2-year warranty period.

Service

Remember, sales receipt is required to prove original ownership (unless you purchased the product online directly from ZipWall®). If there appears to be an actual defect, ZipWall® will ship a replacement. We reserve the right to first require return of the allegedly defective part for inspection (at our expense). We will not accept any invoice deductions from dealers or distributors for defective merchandise.
