

## FUJIFILM NORTH AMERICA CORPORATION - ONE YEAR LIMITED WARRANTY FOR FUJIFILM INSTAX INSTANT CAMERAS

The FUJIFILM Instax Instant Camera ("Product") contained in this package is warranted to the original end user purchaser by FUJIFILM North America Corporation ("FUJIFILM") only against defects in workmanship and materials for one (1) full year from the date of purchase ("Warranty Period") from an authorized FUJIFILM dealer in the U.S.A. This limited warranty does not apply to any Product purchased outside the U.S.A. or from an unauthorized dealer, distributor or seller or any refurbished or reconditioned product. This limited warranty does not cover batteries, flash equipment or any other accessories which may be contained in this package ("Accessories"). This limited warranty is non-transferable and subject to the conditions and limitations set forth herein.

FUJIFILM will, at its option repair and/or replace (with a unit of like condition which may be refurbished), a defective Product that is returned, postpaid and insured, within the Warranty Period to an authorized FUJIFILM Repair Center. If replacement parts are used in making repairs, these parts may be remanufactured or contain remanufactured materials. This limited warranty is the purchaser's sole remedy should the Product be found to be defective. This limited warranty does not apply if the Product has been damaged by accident, mishandling, misuse, abuse, alteration, use with incompatible accessories, a third party device, failure to follow operating or maintenance instructions or if the Product defect or damage is due to services performed by anyone other than an authorized FUJIFILM Repair Center.

In returning the Product for repair, the Product must be delivered in either a cardboard shipping box or in another carton offering a sufficient degree of protection. Do not include any other items or Accessories with the Product. It is advisable to return the Product using a courier service which provides a shipping tracking number. The Product must be accompanied by written evidence of the date of purchase, such as the original dated sales receipt. FUJIFILM will not be responsible for any loss of damage incurred in transit or otherwise in connection with the return of the Product, nor will FUJIFILM be responsible for the return of any items that are included with the Product.
