LIMITED ONE YEAR WARRANTY

GrowlerWerks warrants that your uKeg™ growler (“Product”) will be free of defects in materials or workmanship under normal home use for one year from the date of receipt of product when purchased from an authorized retailer. GrowlerWerks will, at its option, repair or replace a defective Product without charge to you, provided that we are able to verify that the Product qualifies for return under this warranty. You should contact GrowlerWerks directly to obtain a Returned Material Authorization (RMA). If a replacement Product is necessary to service this warranty, the replacement may be new or reconditioned. If a replacement Product is sent, it will carry this same Limited One Year Warranty from the date of receipt. GrowlerWerks will cover pre-approved shipping costs for authorized returns, provided you contact GrowlerWerks for pre-approval prior to shipping your Product. Vendors that accept returned product from a customer should contact GrowlerWerks directly to obtain a Returned Material Authorization (RMA) and to arrange for product repair or replacement.

This warranty only applies to Products operated in the United States. This warranty gives you specific legal rights, and you may also have other rights that vary from state to state. Products operated outside the United States will be supported through online support and through delivery of replacement component parts to be installed by the user with guidance from GrowlerWerks only in cases of approved RMAs for which GrowlerWerks will send replacements parts free of charge.
